With reference to the above cited subject, it is to submit that District Educational Officer, Hyderabad District has submitted a letter to the Addl. Commissioner of Police, Traffic, Hyderabad with a request to inspect the school of M/s. Sri Vidya Secondary School, H.No. 2-2-1105/26/1, Tilak Nagar, New Nallakunta, Hyderabad as they required N.O.C. from Police Department for PTO (Permission to Open) as per required G.O. Ms. No. 41/Edn, Dt: 11.05.2006. The same petition has been received to submit report from traffic point of view.

I have visited M/s. Sri Vidya Secondary School, H.No. 2-2-1105/26/1, Tilak Nagar, New Nallakunta, Hyderabad run by Ekalavya Vidya Samithi and affiliated to CBSE. The school is located on Northern side sub-lane of main road leading from Nimboli Adda T Junction to No. 6 Junction Amberpet, Lane opposite to Salwa Garden function hall and facing towards South. The school is running in its own premises, the building consisting Ground + 3 upper floors. I also enquired neighbors of the school, if they may have any objection to run the school in their locality. The neighbors 1) Sri Girish Ludurkar, 2) Sri Vijay Reddy, 3) Sri V. Shashirekha, 4) Sri Surjit Singh, 5) Sri G. Ramesh, 6) Sri N. Sumalata, 7) Sri Rasheed and 8) Sri Venkat Swamy have informed that they did not have any objection to run the school in their locality. The management of the school also submitted NOC from the neighbors, Self-certification of Annexure-I, building structural, Soundness certificate and Sanitation certificates obtained from the concerned & Self Affidavit duly mentioning the play area and parking details. The management has been providing safe drinking water and better sanitation facility to their students.

In presence of Sri Madhu Sudhan Reddy, Secretary of Sri Vidya Secondary School, H. No. 2-2-1105/26/1, Tilak Nagar, New Nallakunta, Hyderabad and Principal Arathi Jayaram the measurements of school building were taken.

The details of school building measurement s are as follows:

Total Plot area 793 Sq. Yards (or) 663 Sq. Mts.

Thus, the total buildup area Ground + 3 Upper floors come to the extent of 1992 Sq. mts (or) 21441 Sft.

PARKING AREA: The management has shown parking place in the ground floor which is measured and found 496 Sq.mts. with dimensions of 17.7mt.s X 28 mts. In addition to that the management has shown setback area around the school premises for parking place of their school children. On right side set back area measured and found 83 Sq.mts. with dimension of 26mts. X 3.2 mts. and rear side building measured and found 156 Sq.mt.s with dimension of 52 X 3mts. Thus the total parking area available at the school premises is 735 Sq.mts. (496+83+156 Sq.mts).

As per the G.O.Ms.No.86, required of parking place for school is 30% on total buildup area. Accordingly, 1992 @ 30% is 598 Sq.mts., whereas the school management has provided total parking place is 735 Sq.mts. and it is sufficient parking place for this school building.

PLAY AREA: The playground is not available at the premises of the school. So that, the school management has been obtained temporary permission for usage of GHMC Play Ground area of 500 Sq.Mts. at Amberpet Play Ground, for playing Sports & Games of their schoolchildren sanctioned by Games Inspector, Secunderabad Zone, G.H.M.C. The play ground date and time schedule is mentioned in permission copy which enclosed herewith for kind perusal. In Addition to that, the management providing 364 Sq.Mts. play area in the ground floor of the school for Indoor games for their school children as per G.O.Ms.No. 88, Dated: 07-07-2008.

**STRENGH:** The school management has submitted class wise strength particulars of students. The total strength of the school from Nursery to X Class is **1383 students**.

In view of above mentioned circumstances, it is recommended from traffic point of view for issue of N.O.C. to run the classes from PTO (Permission to Open) in respect of Sri Vidya Secondary School, H.No. 2-2-1105/26/1, Tilak Nagar, New Nallakunta, Hyderabad as the school management has provided sufficient parking place, Outdoor and Indoor play area for their school.
